RELEASE OF LIABILITY (WAIVER) FOR PARTICIPANTS

*By Signing the Health Screening Form above, you are also agreeing to the terms of this Release of Liability (Waiver). So, please read before signing.

IN CONSIDERATION OF my child/ward being allowed to participate in any way in the **King of the Mountain Fall Classic 2020** related events and activities, the undersigned acknowledges, appreciates, and agrees that:

The risks of injury and illness (ex: communicable diseases such as MRSA, influenza, and COVID-19) to my child from the activities involved in these programs are significant, including the potential for permanent disability and death, and while particular rules, equipment, and personal discipline may reduce these risks, the risks of serious injury and illness do exist; and,

1. FOR MYSELF, SPOUSE, AND CHILD, I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my child's participation; and,
